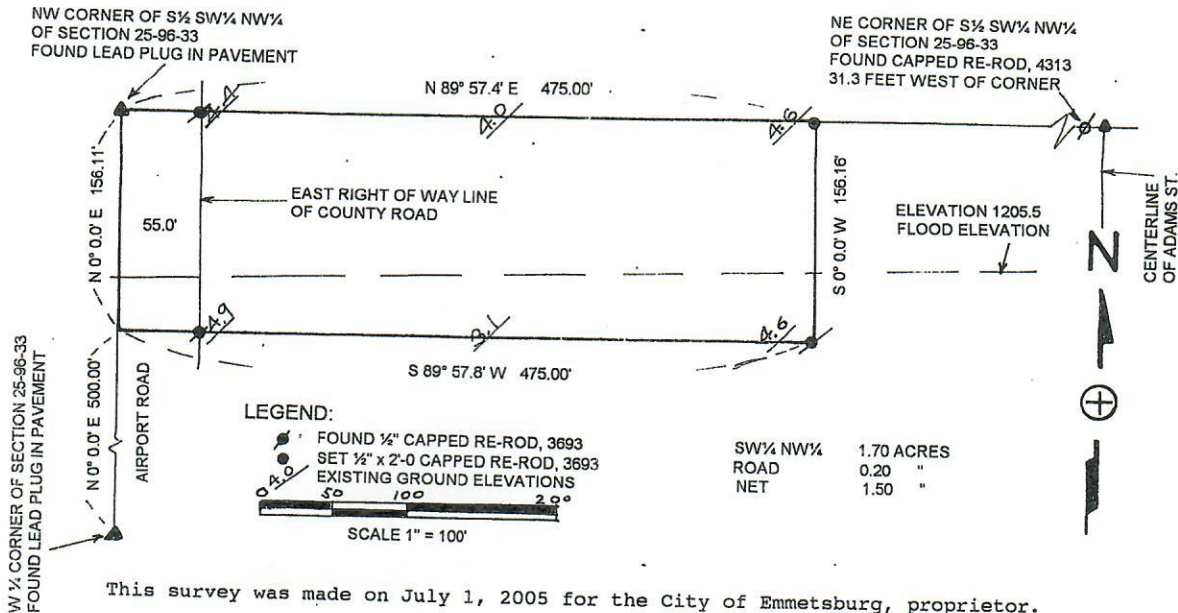


PLAT OF SURVEY

NOTES:

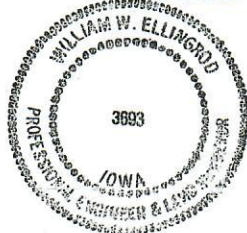
Bench Mark: Top of fire hydrant Southwest of SNC building in Northeast corner of intersection at 17th and Airport Road. Elevation 1207.55, MSL.
Add 1200 to existing elevations shown for MSL elevations.
The flood elevation shown is taken from the FEMA Flood Insurance Rate Map for The City of Emmetsburg, dated September 30, 1993.

DESCRIPTION

A part of the South half of the Southwest quarter of the Northwest quarter (S½ SW¼ NW¼) of Section Twenty-five (25), Township Ninety-six (96) North, Range Thirty-three (33) West of the 5th P.M., Palo Alto County Iowa, described as follows:

Commencing at the West quarter corner of said Section 25, thence North 0 degrees 0.0 minutes East 500.00 feet along the West line of said NW¼ to the point of beginning of the tract to be described:

Thence North 0 degrees 0.0 minutes East 156.11 feet along the West line of said NW¼ to the Northwest corner of the said S½ SW¼ NW¼; thence North 89 degrees 57.4 minutes East 475.00 feet along the North line of said S½ SW¼ NW¼; thence South 0 degrees 0.0 minutes West 156.16 feet to the Northeast corner of a tract deeded to Scott Telephone Company; thence South 89 degrees 57.8 minutes West 475.00 feet along the North line of said Scott Telephone Company tract to the point of beginning, containing 1.70 acres, subject to County Road right of way and any other existing easements. NOTE: The West line of the NW¼ of said Section 25 is assumed to bear true North and South.
